## SCHEDULE OF DOMESTIC FEES 2024

Effective from Term 1, 2024 (All amounts include GST)

Tuition and Boarding fees are an annual fee that requires payment by direct debit (except payment of fees detailed in option 1 below):

#### 1) Full year in advance

Payment of fees in full by 8 December 2023 will be entitled to a 4% discount on the net fee (i.e. after any other discounts have been applied). A direct debit is required for payment of the incidental charges each month.

#### 2) Direct debit by St Peter's School

All fee payers are required to provide a direct debit or credit card authority (credit card merchant fee surcharge applies) for payment of their account.

Tuition and Boarding fees are either billed as four instalments (being 1 Jan, 1 Apr, 1 Jul and 1 Oct) or ten instalments (being 1 January through to 1 October).

#### Incidental charges

The St Peter's School Trust Board appreciates the substantial commitment that parents make in committing to pay school fees and is intent on making payment procedures as convenient as possible.

The monthly direct debit will be the balance outstanding on your monthly statement. This will commence on 22 January 2024 and is payable on 20th of each month.

Dishonoured payments will incur a charge of \$10 in addition to any fees charged by the bank.

#### Notice of Withdrawal

One full term's notice of intention to withdraw from St Peter's School or Boarding, in writing to the Admissions Office is required. Should that length of notice not be given, then a penalty of the next term's fee is payable. The Head of School's discretion may be applied for in exceptional circumstances.

Enrolment in boarding is for the full year unless otherwise agreed. Fee payers accept the responsibility for the payment of the boarding fees for the whole school year or the agreed lesser period for which the student is accepted into the boarding house. Due to the requirements of resourcing the boarding houses, no refund will be offered for students who choose to end their accommodation early due to the nature of their study, for example senior students who in most cases leave the boarding house prior to the end of Term 4, on the completion of their final examinations/assessments.

# SCHEDULE OF DOMESTIC FEES 2024

## **Alumni Membership (Imprest Deposit)**

An imprest deposit (\$250) is payable on entry to the School. The imprest deposit will be converted into fees for life membership of the St Peter's School Alumni Association for your child when they leave St Peter's.

## **Buses**

Buses run from Cambridge, Hamilton (four), Leamington, Maungatautari, Matamata, Matangi, Morrinsville, Putaruru, and Te Awamutu and are available for day pupils. Annual bus fares, payable in 10 instalments will be advised at the start of each year. The details of current bus schedules are available on the St Peter's Community Portal.

## **Camp Fees**

Camp is a compulsory and an integral part of the St Peter's curriculum and charges have been calculated on all students attending. Camp fees are non-refundable and are payable on the same payment cycle as tuition and boarding fees.

## **Campus Development Fee**

The fee is an annual fee of \$1400 payable per student in March towards the repair, maintenance and enhancement of our campus. The fee is non-refundable. If a student enrolls during the year the fee still remains at \$1400.

## **Enrolment Fees**

Application fee     \$ 250 per student – payable at the time of submitting your application to cover administration costs. This fee is non-refundable.

Acceptance fee     \$1,100 per student – is confirmation of acceptance of an offer of a place. This fee is non-refundable and payment is required to secure your enrolment.

## **Lunches**

School lunches are available for all students at no additional cost. Day students are welcome to bring their own lunch, but no refund will be made.

## **Non-Resident Fees**

International fees apply for students who do not have New Zealand or Australian Permanent Residence and whose parents do not have a current New Zealand work permit. Details can be obtained from the International Office.

## **Overdue Accounts**

Interest will be charged on overdue account balances, at a rate of 2% per month.

If fees remain unpaid with no approved payment arrangement in place, St Peter's reserves the right to refuse continued enrolment at the school. Any fees outstanding may be passed onto a debt collection agency, for which the fee payer will be responsible for any associated costs incurred.

## **Pastoral Care**

For students who are paying domestic fees and who do not have caregivers living in New Zealand there will be a charge of \$3,000 to cover the cost of arranging homestays and monitoring student welfare per year.

## **Sibling discount**

A 10% discount off boarding and tuition fees is allowable for the third and subsequent child of a family attending St Peter's concurrently, if no other discounts have been applied to the enrolment of that child.

## **St Peter's Parents' Association**

There is an annual charge for membership of the St Peter's Parents Association (\$60 per family).

## **Withdrawal from School prior to commencement**

A payment of one term's fees will be required to be paid for circumstances where notification of a withdrawal from School prior to your child commencing, is received.
