## SCHEDULE OF FEES FOR INTERNATIONAL STUDENTS 2022

Effective from Term 1, 2022

All amounts are shown in NZ\$ and include Goods and Services Tax (GST)

### Fees and Enrolment Expenses

Outlined below is a comprehensive summary of all fees and costs at St Peter's School, Cambridge.

International Tuition Fees: (Years 7-8)	\$41,200 per annum
International Tuition Fees: (Years 9-10)	\$46,800 per annum
International Tuition Fees: (Years 11-13)	\$48,800 per annum
Acceptance Fee	\$1,000
Imprest Deposit (Alumni Membership)	\$250

### Accommodation

Boarding Fee	\$16,975 per annum
Homestay for Boarding students for leave weekends and holidays (estimated)	\$3,000 per annum
Homestay for Day students (45 weeks)	\$13,230 per annum

The St Peter's School Trust Board review fees on an annual basis.

### Other Expenses (Estimated)

Medical Insurance	\$590 per annum
Uniform costs for new students	\$1,600-\$1,800
Bus (Day students)	\$1,400-\$2,500
Examination Fees	\$400-\$800

Please note that there will be other **discretionary expenses** which may be charged to a student's account. These types of disbursements vary from student to student, but typically range between NZ\$2,500-\$3,500 per year.

## Miscellaneous Charges

Acceptance Fee – non refundable  
(payable only once)

\$500 (for 2nd and subsequent children

## Payment of Fees and Disbursements

Tuition fees include provision for English as a Second Language (ESOL) tuition. Full payment in advance must be received by 30 November each year.

## Payment options

### 1. Credit Cards

Only **Visa** or **Mastercard** will be accepted however a surcharge fee of 2.7% will be added to cover transaction costs where this option is chosen.

### 2. Direct Credit

Payments may be credited direct to the school's bank account:

### 3. Direct Debit from a New Zealand bank account.

Monthly disbursements can be paid by variable direct debit from your bank account on the 20th of the month following invoice.

## Overdue Accounts

Interest will be charged on overdue account balances, at a rate of 2% per month.

## Notice of withdrawal

One full term's notice of intention to withdraw from St Peter's School, in writing to the Principal is required. Should that length of notice not be given, then a penalty of the next term's fee is payable. Principal's discretion may be applied for in exceptional circumstances.

Notice of intention to withdraw from boarding to become a day student requires one full term's notice except after Week 6, Term 3. In this situation, a penalty of boarding fees until the end of the year is payable.

## Imprest Deposit (Alumni Membership)

An imprest deposit (\$250) is payable on entry to the School. The imprest deposit will be converted into fees for life membership of the St Peter's School Alumni Association for your child when they leave St Peter's.

## St Peter's Parents' Association

There is an annual charge for membership of the St Peter's Parents Association (\$60 per family).

## Buses

Buses from Cambridge, Hamilton (four), Leamington, Maungatautari, Matamata, Matangi, Morrinsville, Putaruru, and Te Awamutu are available for day pupils. The price is advised prior to the start of each year; payment is in eight instalments. The details of current bus schedules are available from the School Office.

## Non-Resident Fees

International fees apply for students who do not have New Zealand or Australian Permanent Residence and whose parents do not have a current New Zealand work permit. Details can be obtained from the International Office.

For international students who have New Zealand residency and are paying domestic fees who have been introduced to the School through an agent, an annual fee of \$6,000 will be payable.

## Pastoral Care

For students who are paying domestic fees and who do not have parents living in New Zealand there will be a charge of \$2,000 to cover the cost of arranging homestay's and monitoring student welfare per year.

## Multi-pupil discount

A discount of 10% off boarding and tuition fees is allowable for the 3rd and subsequent children of a family attending the School concurrently.

## Lunches

School lunches are available for all students at no additional cost. Day students are welcome to bring their own lunch, but no refund will be made.

## Transition to Domestic Status

Students who enrol as International students and later qualify for the Ministry of Education subsidy will be charged domestic fees after giving one Term's notice in writing.
